Description:

This policy provides reimbursement guidelines for Intensity Modulated Radiation Therapy (IMRT) services submitted by contracted and non-contracted Clover Health providers for all Clover Medicare Advantage plans. Providers submitting under the same group tax identification number will be considered the same provider.

Definitions:

- Intensity Modulated Radiation Therapy (IMRT) - a computer-based method of planning for, and delivery of generally narrow, patient specific, spatially and often temporally modulated beams of radiation to solid tumors within a patient.

Policy:

Clover Health will follow the American Medical Association (AMA) and the Centers for Medicare and Medicaid Services (CMS) National Correct Coding Initiative (NCCI) policy for IMRT services.

CPT codes 77280-77290 (simulation-aided field settings), should not be reported separately from 77301 unless these services are related to distinct non-IMRT radiation for a different tumor.

Simulation services CPT codes 77014, 77280, 77285, 77290, 77295, 77306 through 77321, 77331, and 77370 should not be reported in addition to CPT code 77301 (IMRT planning) when the services are reported prior to or part of the IMRT plan. These services are included in the payment for 77301 and will not be reimbursed separately.
