## SECTION I - INTRODUCTION TO SUMMARY OF BENEFITS

### What do we cover?

Plans may offer supplemental benefits in addition to Part C benefits and Part D benefits. Like all Medicare health plans, we cover everything that Original Medicare covers – and more. Some of the extra benefits are outlined in this booklet.

We cover Part D drugs. In addition, we cover Part B drugs including chemotherapy and some drugs administered by your provider.

### How will I determine my drug costs?

Our plan groups each medication into one of five “tiers.” You will need to use your formulary (Drug List) to locate what tier your drug is on to determine how much it will cost you. The amount you pay depends on the drug’s tier, what pharmacy you use, and what benefit stage you have reached. Later in this document we discuss the benefit stages that occur: Deductible Stage, Initial Coverage, Coverage Gap and Catastrophic Coverage.

For 2023, **Clover Health LiveHealthy (PPO) (plan 050)** participates in the Part D Senior Savings Model which offers lower, stable, and predictable out of pocket costs for covered insulin through the different Part D benefit coverage stages. You will pay \$35 for a 1-month supply, \$70 for a 2-month supply, or \$105 for a 3-month supply of covered insulin during the initial coverage and coverage gap or “donut hole” stages of your benefit. Catastrophic phase cost shares would still apply. You are not eligible for this program if you receive Extra Help. To find out which drugs are Select Insulin Drugs, review the 2023 Drug List.
